7. Club Affiliation Fees:

EA Affiliation Fees have been paid for the club and coaches, however whilst there are no competitions and in line with the extension of the athlete EA registration date (until 31st August 2020), no member would be registered with EA at this time.

No membership would be charged whilst training is suspended, and all 2019/2020 memberships are extended until 31st August 2020. Membership fees and athlete EA registration will be reviewed on a monthly basis.

8. Return to Training:

At the time of the AGM we are still a long way from returning to normal training activity, particularly with the leisure centre and track itself closed. However, Graham, Danny, David and Kathryn will provide endurance coaching (speed sessions) to athletes in Rushcliffe Country Park at 7pm on Tuesdays (starting 24th June). This comes with a lot of conditions and will be expanded as an when we have the capacity to do so. Current restrictions allow for groups of no more than 6, Coach:5 athletes, to socially distance train. As and when coach capacity and restrictions/guideline allow this will be expanded.

Caitlin Sorrell thanked the committee & coaches for their efforts in staying in touch with the members during the lockdown and continuing suspension of training. She gave an update on the current guidelines which include the requirement for a Covid-19 Co-ordinator for the Club. Whilst she was happy to take on this role she did ask if there was a member with a H&S background, which is the preferred EA option.

Harvey Sugden, who is NEBOSH qualified offered to take on the role and is now RAC Covid-19 Co-ordinator.
